Ford Powertrain Service Part Warranty Registration

To Register a New Service Part Warranty:

- 1. Complete the form to register your eligible Powertrain Service Part Warranty.
- 2. Prior to selecting a "Submit", review your entries for accuracy.
- 3. Select "Submit" to register the Warranty.
- 4. Once you have selected submit, you will receive a confirmation number, and a copy of the Limited Warranty Statement with the information you provided. Please print two copies, one should be provided to the customer for their records and one should be kept on file for the Dealership's records.
- 5. The customer should also be provided with a copy of their original invoice and/or Repair Order for proof of purchase. The customer should retain these documents with their vehicle.
- 6. Within 24 hours of submission, a Powertrain Warranty indicator should be visible in OASIS for the recorded VIN

To Revise an Existing Service Part Warranty Registration:

- 1. Input P&A code, VIN or Confirmation Number and select the "Search/Edit" button at the bottom of the page.
- 2. Select the record you wish to correct. You will be redirected to the original submit screen.
- 3. Make the necessary corrections and select the "Submit" button at the bottom of the page.
- 4. Once you have selected submit, you will receive a confirmation number and a copy of the Limited Warranty Statement with the information you provided. Please print two copies, one should be provided to the customer for their records and one should be kept on file for the Dealership's records.
